RELEASE OF CLAIMS
MT. PISGAH UNITED METHODIST CHURCH

I represent that I am the parent/legal guardian of _____, who is under 18 years of age ("my child"). I hereby give permission for my child to participate in the various programs, events, and activities of Mt. Pisgah United Methodist Church (the "Church"), both on Church premises and elsewhere. In consideration of the opportunity of my child to participate in the various programs, events, and activities of the Church ("Activities"), I hereby freely, voluntarily, and without influence from anyone or duress of any kind, release the Church, its officers, directors, leadership, agents, employees, and volunteers (collectively "Church Affiliates") from any and all liability of any kind whatsoever for loss, harm, injury, or illness to my child arising from Activities on or off the premises of the Church or resulting from travel to or from Activities of the Church.

ASSUMPTION OF RISK. I understand that Activities of the Church may be hazardous to my child. These Activities include, but are not limited to, the following: camps, mission trips/ projects, recreational activities, team sports, social activities, special events, field trips, and/or other physical activity to be performed in connection with Activities of the Church. I willingly allow my child to engage in all such Activities, and I knowingly assume on behalf of my child the risks of loss, harm, injury, and illness and all other risks associated with Activities of the Church, including any loss, harm, injury, or illness caused by the negligence, fault, or misconduct of any kind on the part of any Church Affiliates. Additionally, I acknowledge there may be other risks inherent in these Activities of which I may not presently be aware.

RELEASE AND WAIVER. I, ON BEHALF OF MYSELF AND MY CHILD, HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE, WHETHER IN LAW, EQUITY, OR OTHERWISE, AGAINST THE CHURCH AND CHURCH AFFILIATES (AS DEFINED ABOVE), TO THE FULLEST EXTENT PERMISSIBLE BY LAW. THIS RELEASE AND WAIVER INCLUDES BUT IS NOT LIMITED TO CLAIMS RELATING TO NEGLIGENCE OR FAULT OF ANY KIND ON THE PART OF THE CHURCH OR CHURCH AFFILIATES. THIS RELEASE AND WAIVER INCLUDES (WITHOUT LIMITATION) ANY CLAIM FOR DAMAGES RELATING TO DEATH, BODILY OR PERSONAL INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, LOSS OR DAMAGE TO PROPERTY, AND OTHER DAMAGES WHICH MY CHILD (OR HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES OF MY CHILD) MAY HAVE OR WHICH MAY HEREAFTER ACCRUE ON MY CHILD'S BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY CHILD'S ATTENDANCE AT, PERFORMANCE OF, AND/OR PARTICIPATION IN ACTIVITIES OF THE CHURCH.

EFFECTIVE DURATION. I understand and agree that this release and waiver will apply to and govern my child's participation in any and all activities, programs, and/or events associated with or offered by the Church or in which the Church participates. I understand and agree that this release and waiver shall remain in effect until revoked in writing by me.

MEDICAL TREATMENT. I hereby grant permission to the Church and Church Affiliates to render preventative or first-aid assistance and to seek any treatment or medical care that they deem to be reasonably necessary, including hospitalization, for the health and well-being of my child. I hereby release and forever discharge the Church and Church Affiliates from any claim whatsoever which arises or may hereafter arise on account of any first-aid, treatment, or medical care rendered to my child in connection with Activities of the Church. I understand and agree that I will be financially responsible for any such care provided to my child. Additionally, I understand that it is my responsibility to update with the Church my child's medical and insurance information as soon as changes occur.

Model Consent and Release Agreement

FOR USE IF INDIVIDUAL IS A MINOR

I represent that I am the parent/legal guardian of _____, who is under 18 years of age ("my child"). For and on behalf of my child, I hereby agree to the terms of this Model Consent and Release Agreement ("Agreement"), in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged. This Agreement is effective on the date signed.

1. I understand that Mt. Pisgah United Methodist Church (the "Church") may photograph/videotape during or at services, programs, events, and activities of the Church. For and on behalf of myself and my child, I consent to use by or on behalf of the Church without charge or restriction of my child's name, voice, likeness, image, performance, photographs, video, and biographical and historical information, in whole or part, for educational, informational, and promotional segments on the Church's website, Church-affiliated social media channels, other materials, media distribution, or for any lawful use.
2. For or on behalf of myself and my child, I hereby irrevocably sell, assign, and convey to the Church, and its officers, directors, leadership, agents, employees, volunteers, affiliates, and others working on its behalf, and its respective licensees, successors, and assigns (collectively, "Assigns"), the absolute, irrevocable, and unrestricted right and permission to copyright and use, re-use, edit, mix, duplicate, exhibit, distribute, broadcast, publish and republish my child's name, likeness, image, voice, sounds, appearance and performance (collectively "Material") in which my child may be included, without restriction as to changes or transformations in electronic, digital, printed or any other form, in any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever anywhere in the world. I acknowledge that this Agreement does not in any way conflict with any existing commitment on my part or on the part of my child.
3. For and on behalf of myself and my child, I hereby relinquish any right that I or my child may have to examine or approve the Material or the use to which it may be applied. The Church and its Assigns shall have the unlimited right to exploit and edit the Material as they see fit. I understand that nothing contained herein shall obligate the Church or its Assigns to make any use of the Material or the rights granted herein.
4. I acknowledge and agree that full and complete consideration has been provided for my child's services and for the permissions and rights which I have granted herein. Neither I nor my child are entitled or shall be entitled to receive any additional incentive, compensation, residual payment or other consideration.
5. For and on behalf of myself and my child, I hereby release, discharge and agree to hold the Church and its Assigns, and their respective officers, directors, leadership, employees, volunteers, representatives, agents, and affiliates, harmless from any and all claims, regardless of form or origin, arising from the creation, use or distribution of the Material, including without limitation any claims for libel, or invasion of my rights or my child's rights of privacy and publicity, and claims relating to any distortion or illusory effect.
6. I affirm that I am over the age of 18 and have the right to contract in my own name and on behalf of the minor child identified above. I have read and fully understand the above authorization and release prior to its execution. This Agreement shall be binding upon me, my child, and my child's heirs, legal representatives and assigns.

YMCA Camp Cheerio Release and Waiver

The term "Activities" for purposes of this release and waiver shall mean any and all activities arising out of or associated with the YMCA Camp Cheerio (as defined below) and whether or not such activities occur on or off of facilities or property of YMCA Camp Cheerio.

The term "Participant" means collectively, the undersigned and the undersigned's spouse, child, and family, including but not limited to any minor for which Participant is guardian or otherwise under the care and supervision of the undersigned. Participant executes this release and waiver on behalf of his or her self and all other parties defined as Participant.

"YMCA Camp Cheerio" shall mean The Young Men's Christian Association of High Point, Inc., a North Carolina non-profit corporation, and its programs known as Camp Cheerio, Cheerio Adventures, and any other programs of the foregoing as well as their respective employees, directors, officers, members, and agents.

- **(a) Assumption of Risk/Release and Waiver.** Participant acknowledges and understands that there are inherent risks involved in the Activities for which Participant will engage. Participant assumes all inherent risks and other risks of the Activities and accepts responsibility for any property damage and loss for any personal injury, illness, disability, emotional distress, and/or death that Participant may suffer. Participant acknowledges YMCA Camp Cheerio does not provide accidental injury insurance. In consideration of YMCA Camp Cheerio allowing Participant to participate in the Activities, Participant agrees to release, waive, discharge, covenant not to sue, hold harmless, and indemnify YMCA Camp Cheerio from any and all claims, causes of action, liability, losses, costs, or damages arising out of or related to any property damage, property loss or theft, personal injury, disability, death or loss suffered or incurred by Participant arising out of or connected with the Activities. The undersigned Participant acknowledges that he/she has read this release and waiver and understands all of its terms. This undersigned executes it voluntarily and with full knowledge of its meaning and significance.
- **(b) Certification of Ability to Participate, Medical Authorization, Permission to Treat.** Participant hereby certifies that to the best of Participant's knowledge, Participant is able to safely participate in the Activities for which Participant is registered. Participant hereby acknowledges that YMCA Camp Cheerio does not provide medical services for rental groups, and recommends that each group provide an individual with a minimum of current certification in Red Cross Standard First Aid/CPR (or equivalent.) In the event of a severe accident or injury, YMCA Camp Cheerio staff will call 911 and activate Emergency Medical Services. All transportation to advanced medical care will be given by EMS or by a member of the rental group. This release and waiver may be photocopied.
- **(c) Photography.** Photographs, film, video, or other images may be taken of Participant during Activities. Participant consents to the use of images of Participant for displays, brochures, videos, and other promotional materials with no compensation to Participant.
- **(d) Trips and Outings.** Participant gives his/her permission for any Participant who is a minor to leave the camp grounds with authorized YMCA Camp Cheerio staff for scheduled trips and outings.
- **(e) Rules and Regulations.** Participant agrees to at all times adhere to all rules and regulations of YMCA Camp Cheerio and acknowledges receipt of such rules and regulations with regard to Participant's applicable Activities.
